## Violence in the Schools

Educational opportunities for the African American student in the nation's public school system has been undermined by crime, violence and substance abuse. It is common knowledge that it's roots are embedded in poverty, racism, joblessness and hopelessness.

Community violence extends to the academic environment. Changes in school policies and the way schools deal with the growing number of violent incidents are necessary.

## **Collaborative Programs**

Listed below are some of the initiatives under-



taken that are producing positive results within the school system:

- Educate local and state policymakers, service providers, and the public about the impact of violence on children and communities.
- Educators are being trained to recognize the signs and symptoms of children exposed to violence.
- Community members are taking an active role in learning more about the research related to the impact of violence on children.
- School districts, in response to local

needs, have stepped up efforts to improve school security by installing security aids or devices.

- Establishing Neighborhood Watch programs in areas near schools.
- Completing criminal background checks on teachers and school staff members before a work assignment is made.
- Creating block safety watch programs carried out by area residents at school bus stops as a crime deterrent for school children and area residents.
- Equipping classrooms with intercom systems connected to the central school office.
